The National Planning Forum

- is the only cross-sectoral forum focusing on spatial planning in England with a mission to inspire planning and planners
- has a membership of over 70 organisations representing the key national organisations with a role in, and commitment to, planning
- acts as a critical friend to the Planning Directorate within the Department of Communities and Local Government, helping to inform and shape policy by reflecting significant depth of experience of practice
- informs debate, builds cross-sectoral consensus and provides clarity on the issues where views differ
- operates as a membership network with a web-site that is open to all
- is committed to ensuring that spatial planning in England is fit for purpose
- provides a platform for all the sectors to engage in discussion and debate on key planning issues - identifying consensus and clarifying difference

The Forum embraces the five sectors of business, local government, the professions, the non-governmental and voluntary sector and planning in central government. It operates on an entirely non-political basis and represents a unique body of cross-sectoral experience. It is a valuable tool as both a 'sounding board' for new policy and practice initiatives and as vehicle for exploring new approaches to planning process such as, for example, our current work investigating the potential to use mediation as a way to resolving disputes in planning.

Changed circumstances

- In 2008/09 the collapse of banks in Europe and the USA led to the 'credit crunch' and a subsequent major down turn in world economies.
- In the UK this led to recession and uncertainty about growth prospects; property and housing values fell; a more risk aware banking sector began to restrict credit and unemployment in the private sector rose.
- In May 2010 a new Conservative/Liberal Democrat government came to power with a radical agenda to introduce a decentralising, 'localism' approach to decision-making; create a 'Big Society'; reform welfare and benefits; re-balance the economy to promote private sector growth and respond to the economic crisis with a major programme of reductions in public expenditure.

As part of this reform agenda the Coalition Government is introducing a major change programme for both the practice and the culture of spatial planning, which will be delivered through the Decentralisation and Localism Bill:

- Regional spatial strategies, regional development agencies, government offices, regional leaders' boards and 'top-down' targets for housing will be abolished and planning decisions made by local government alone.
- There will be a National Planning Policy Framework and National Infrastructure Plan for England.
- As the local planning authority, local government will be responsible for preparing a development plan, incorporating neighbourhood aspirations, supported by a strategic housing market assessment. There will be a general power of competence and a duty to co-operate and a presumption in favour of sustainable development.
- Neighbourhood-based community groups will be encouraged to engage in plan-making as part of a transfer of power to local communities.
- Local authorities will be incentivised to build new homes through the 'new homes bonus'. There will be a 'community right to build' and there will be major reforms to social housing policy, including 'affordable rents'.
- The Infrastructure Planning Commission will be abolished and replaced by a Major Infrastructure Planning Unit as part of the Planning Inspectorate

and will advise ministers on the determination of development consent orders.

- Local authorities and local business will be invited to form Local Enterprise Partnerships to address cross-boundary economic growth and deliver infrastructure.
- A major programme of abolishing, merging, and re-configuring arms-length and non-departmental public bodies is underway, which inevitably impacts on a number of members of the National Planning Forum. The Audit Commission, Commission for Architecture and the Built Environment, the Commission for Rural Communities, the Regional Development Agencies Network and the Sustainable Development Commission are to be abolished and a number of others will have major reductions in budgets and staffing levels and significant re-configuration of roles and responsibilities.

Changed direction

The NPF Board has addressed the radical nature of these changes, the pace with which they are proceeding, the impact of unprecedented cuts in public expenditure, and the potential impact in the private sector, and has recognised that they will significantly impact on the Forum. It is likely that a number of Forum members will no longer exist, while new organisations may emerge. In the short term, Forum-member energies will be directed internally while organisations plan for a different future; all will be coping with a new policy environment and smaller budgets and others will be exploring new opportunities and operating environments in the new policy context.

The Board's view is that in this changing environment, the priorities for the Forum through to March 2012 are:

- Enabling practitioners to engage in the debates about a new way of doing planning – especially around the **Decentralisation and Localism Bill**.
- Developing new **spatial planning practice** including:
 - Understanding and enabling **localism** at neighbourhood level;
 - Preparing 'bottom-up' **development plans**;
 - Preparing and monitoring the **National Planning Policy Framework**;

- Addressing the need for ‘joined-up’, cross boundary planning and delivery mechanisms to be built from the ground up, particularly through **local enterprise partnerships**.
- Understanding the new mechanisms for setting and delivering **housing** targets at local level, including affordable housing.
- Identifying and publicising **best practice** in both urban and rural contexts.
- Ensuring Forum members continue to be **informed about and comment upon** the changing policy environment.
- Identifying and enabling the **new skills and new practices** required to deliver the ‘new’ planning across the sectors as public, private and third sector practitioners engage with new processes at neighbourhood, local, larger than local and national levels.
- **Supporting all the sectors** in a new system where local government will be even more ‘centre stage’ and all sectors will be addressing new roles, relationships and skill requirements.

A new agenda

In the light of these changed and very different circumstances it is clear to the Board that the National Planning Forum remains as relevant as ever - both as a place for members to engage with the new agenda from a cross-sector perspective and as a critical friend to and sounding board for government as new policies and practice emerge.

The Forum is uniquely placed to provide thought leadership to spatial planning in England and will use the experience and perspective of its membership to support the new techniques, skills and cultures the new planning emerging from the Decentralisation and Localism Bill requires.

The priorities for the Forum in 2010/12 are:

- **Engaging with the new planning agenda:**
 - Providing members with information and the opportunity to comment on changing policies and practice.

- Using the experience of Forum members to provide advice to ministers and officials around the Decentralisation and Localism Bill and its implementation.
- Contributing to the development of new policies and practice through comment and research based on the Forum's unique, cross-sector membership; particularly in relation to:
 - the National Planning Policy Framework
 - Localism, including both neighbourhood and local planning
 - Local Enterprise Partnerships and spatial planning; and
 - Infrastructure delivery.
- **Supporting the new planning through NPF projects:**
 - Implementing *Mediation in Planning*.
 - Building on *Improving the Connection – improving the relationship between planning and building control in the context of sustainability*.
 - Using the experience of the Forum to provide the tools to support *Localism in Practice*.
- **Developing awareness of the NPF, improving the service to members and making the archive more widely available:**
 - Refreshing the website.
 - Producing a regular email newsletter.
- **Growing the membership:**
 - Adopting a more flexible membership structure without diluting the Forum's strength as across-sector organisation of representative organisations.
 - Increasing the number of members in each sector and ensuring new and re-configured spatial planning and allied organisations are invited to become members.
 - Publicising the benefits of membership through the website, exhibiting at targeted events, placing editorial material in key journals.
- **Growing and broadening the resource base:**
 - Actively pursuing the 'every member contributes' strategy to member subscription income.
