## MEDIATION IN PLANNING PROJECT

### NEWSLETTER 1: DECEMBER 2009

**Progress to date:** This joint project is designed to assess the potential value of using mediation in the planning system by testing the use of mediation techniques in a variety of planning disputes including major development, enforcement and plan-making. It is supported financially by the Planning Advisory Service (PAS) as well as the National Planning Forum (NPF) and Planning Inspectorate (PINS).

A cross-sectoral steering group of NPF members<sup>#</sup> led by Leonora Rozee, former Deputy Chief Executive of the Planning Inspectorate, has been set up to help shape the project. A number of the cases originally notified to us have proved not suitable for one reason or another. However 2 live mediations are being pursued already - one enforcement case and one Area Action Plan (AAP) - and we are actively investigating 5 cases with the expectation that we will undertake a total of 4 live case studies. Mediators are assigned by the Chair of the Project following a competitive tender process. We are also reviewing 4 completed mediations undertaken prior to the project to see what lessons can be learnt, and will follow up on all cases drawn to our attention even if they do not lead to a mediated outcome.

We remain keen to hear from anyone who has views on the potential of mediation as a means of improving the effectiveness of the planning system.

**Evaluation:** An evaluation process has been developed to ensure that the views of the parties to the dispute, and the mediation process, will enable the lessons learned from the case studies to be properly understood. The tender for this work has been let to Chrissie Gibson, Connectivity Associates Ltd and Scott Jones, Mind-the-Gap Research and Training.

**Resources:** £35k has been allocated for the project, £20k from the NPF, £5K from PINS, and £10k from PAS. The project is paying for the mediators and evaluation. All mediators are qualified and experienced in planning mediations. The mediation session(s) are being set up by the mediator assigned to the case by the SG. One or two mediators, an evaluator and the Project Chair will attend the sessions, and the key issues and result of the mediation will be reported - excluding any confidential information - in the Evaluation Report.

**Timetable:** The mediations will be carried out from December 2009. An interim report will be delivered to the March 2010 NPF meeting and a final report in June 2010.

**The results:** The report documenting the process and giving the results will be written by Leonora Rozee with inputs from the evaluators and others. We have a bibliography of learned papers and other references to the use of mediation in planning both nationally and internationally. If you think you have material to input that we may not have discovered please let us know.
