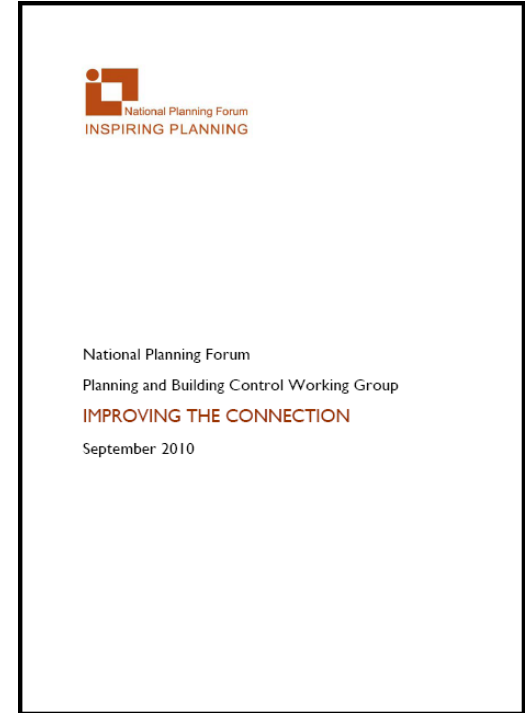

- Increase knowledge and awareness

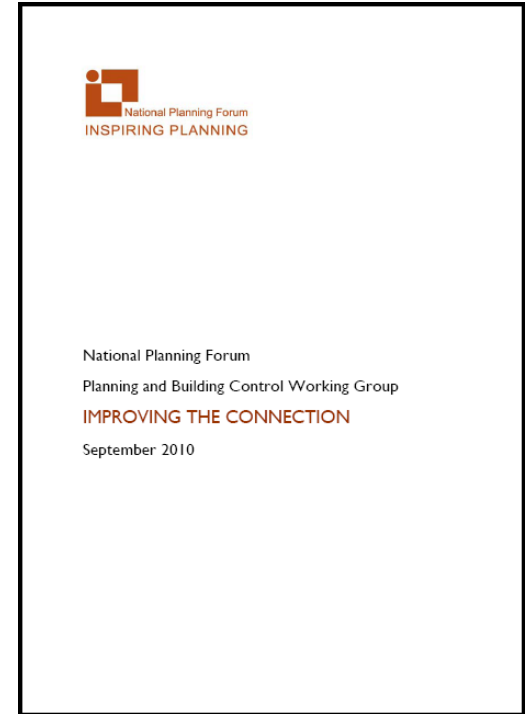

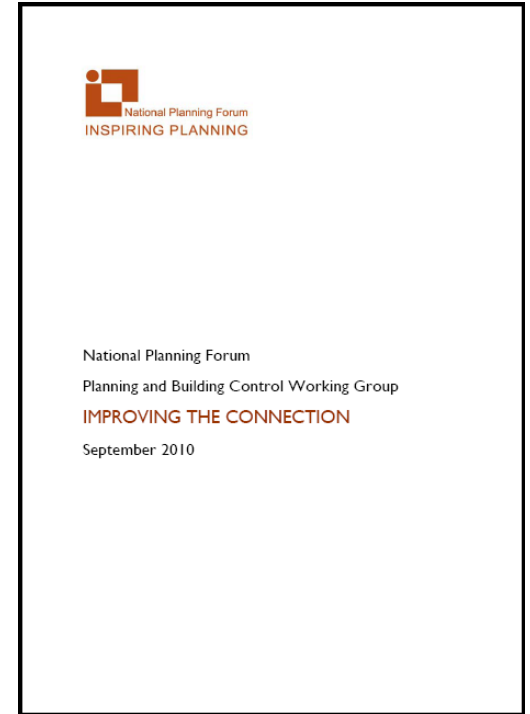
Improving the links to achieve better service outcomes through:

Improving the Connection

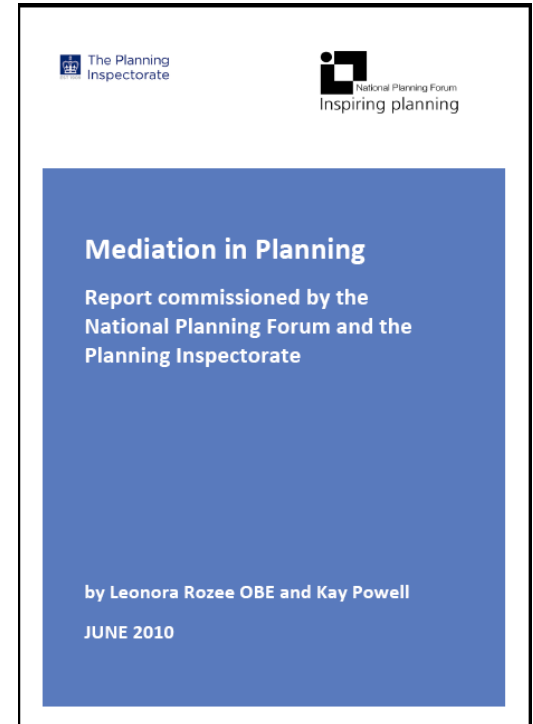
- Published (finally) in September

Mediation in Planning

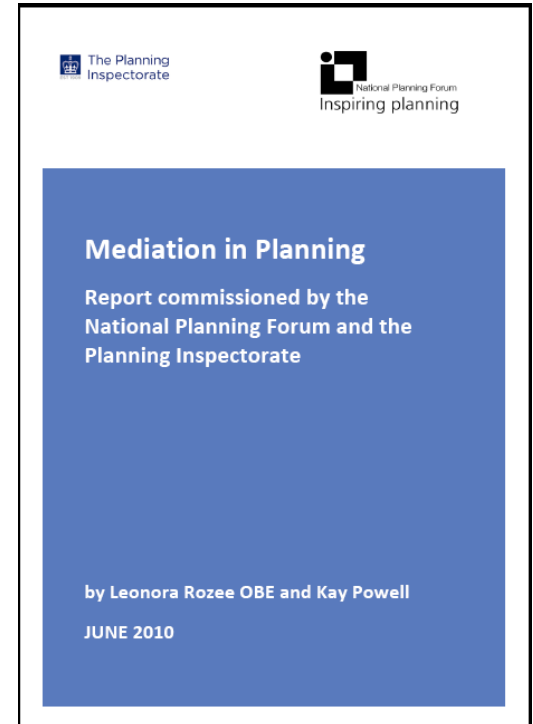

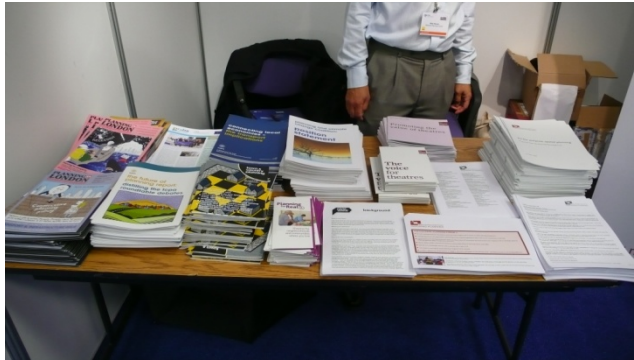


Mediation in Planning

Proposal

- The Forum continues to grow its membership across the five sectors attracting organisations engaged in policy and practice in spatial planning.
- Additionally, the Forum creates an Associate Member class – open to individual (i.e. non-representative) companies or organisations in the public, private and voluntary sectors.
- Admittance to Associate membership will be at the discretion of the Board and will require the payment of an annual subscription.

Vice-chair for Government Agencies

The role involves joining the Executive Board as the advocate for planning and planners within Government Agencies in discussions on the direction of the NPF and the issues it should debate.

The minimum requirement is for attendance at four Executive Board meetings a year in central London, in addition to the four Forum meetings. In addition, the previous vice-chair commenced regular 'sector meetings' (held immediately prior to Forum meetings), which have proved useful in bringing the sector together to discuss issues of common concern. Vice-Chairs are also expected to offer to lead on particular pieces of work e.g. by chairing a Task and Finish Group, from time to time.
